Authorizing the Tehachapi Valley Recreation and Park District to enter into an amendment for Contract No. C9801263 with the State of California for the Per Capita

Grant Program Under the California Drought, Water, Parks, Climate, Coastal Protection, and Outdoor Access for All Act of 2018.

WHEREAS, the Tehachapi Valley Recreation and Park District will enter into an Amended Contract with the State of California to increase the Tehachapi Valley Recreation and Park District Per Capita Grant Fund allocation from \$190,176.00 to \$376,482.00 to reflect the pass through of \$186,306.00 from the City of Tehachapi.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Tehachapi Valley Recreation and Park District hereby:

- 1. Approves the Amendment to Contract No. C9801263 with the State of California under the Per Capita Grant Program under the California Drought, Water, Parks, Climate, Coastal Protection, and Outdoor Access for All Act of 2018; and
